

Footnotes: <sup>1</sup> Women who do not want any more children or want to wait at least 2 years before their next birth but are not currently using a method of FP. <sup>2</sup> Skilled provider is a doctor, nurse, midwife, or clinical officer. <sup>3</sup> Basic antigens include BCG, rotavirus, DPT-HepB-Hib, pneumococcal, OPV, IPV, and MR. <sup>4</sup> County-level childhood mortality rate estimates are for the 10-year period before the survey and national level childhood mortality rate estimates are for the 5-year period before the survey. <sup>a</sup> Kenya total is among counties where IPTp is implemented. Busia County does implement IPTp.


#### **Total Fertility Rate**

Average number of births per woman for the 3-year period before the survey




#### Delivery by a Skilled Provider

Percent of births in the 2 years before the survey delivered by a skilled provider




#### **Use of Modern Methods of Family Planning**

Percent of married women age 15-49 using a modern method of family planning




#### **Basic Antigen Vaccination Coverage**
