



Average number of births per woman for the 3-year period before the survey




Delivery by a Skilled Provider Percent of births in the 2 years before the survey




Use of Modern Methods of Family Planning

Percent of married women age 15-49 using a modern method of family planning




Basic Antigen Vaccination Coverage Percent of children age 12-23 months who
