


## Vihiga County: Key Indicators from the 2022 KDHS

Average number of births per woman for the 3-year period before the survey




**Delivery by a Skilled Provider** Percent of births in the 2 years before the survey




## Use of Modern Methods of Family Planning


Percent of married women age 15-49 using a modern method of family planning
